Whereas, the outbreak of deadly global pandemic COVID-19 and the "**21 day lockdown**" announced by the Hon'ble PM has paralyzed the day to day life, the adverse impact on containerized EXIM trade all across India including JNPT is a matter of great concern Whereas, Ports and Terminals continue to function in order to ensure that supply chain is not disrupted, We Sarveshwar Logistics Services Pvt Ltd as an extension of the Ports, despite operational constraints & challenges, we have kept our facilities open and the CFS has remained functional.

As per the directives of the Government, whereas, in this hour of crisis, proactive facilitation measures initiated by Shipping Ministry, Special Secretary (Logistics), JNPT, JNCH & other Custom Houses, Nhava Sheva Police, District Collector Raigad, Gram Panchayat and several other Governmental agencies are unprecedented and with their intervention and advise, **Maharashtra Government in the amended "lockdown order" dated 24th March 2020 vide para 3(b) have categorically declared "CFSs, Warehouses and offices of CHAs are being essential services initiatives have greatly facilitated all the stakeholders and service providers like Ports, Terminals, CFSs, Truckers, CHAs and all other Logistics service providers to some extent shall be excluded from the restrictions"**. These whereas, Ports / Terminals & Sarveshwar Logistics Services PVT LTD are functional albeit with reduced staff, it is matter of grave concern that the quantum of deliveries has been negligible: -

- 1) Sarveshwar Logistics Services Pvt Ltd hereby inform all our valued customers that our CFS have consistently been evacuating Import laden boxes from all the Terminals and despite constraints and shortage of TT drivers have **collectively evacuated over 1600 TEUS from Terminals at JNPT from 22nd March 2020 to 02nd April 2020**, however the valued customers have hardly taken any deliveries in last 10 days.
- 2) This is resulting in piled up of large number of Import laden inventory in our CFS and with only a fraction of Imports being gated-out by the trade, we Sarveshwar Logistics Services Pvt Ltd and the CFSs located at vicinity of Nhava Sheva unprecedented challenge and it is apprehended that **in current scenario, most of the CFSs will reach their "holding capacity" and evacuation from are facing and terminals will come to a halt. This inter-alia would have a cascading effect on Port inventory and lead to congestion in ports.**
- 3) In view of above we appeal to all our customers to commence taking deliveries of Import laden containers from the CFS. As already mentioned, Sarveshwar Logistics Services PVT LTD **CFS is functional and Documentation / Delivery/ payment counters are open from 09:30 AM to 8:00 PM.**
- 4) We also wish to reassure the trade and especially all customers / visitors coming to CFS in connection with clearances and deliveries of boxes that our CFS as responsible stakeholders and citizens are committed to combating and containing the spread of deadly COVID 19. Accordingly, Sarveshwar Logistics Services PVT LTD. **CFS have taken utmost care and initiated several Safety and Health related precautionary measures keeping in mind the health of their own staff and also the persons visiting CFS for clearance of goods to contain the spread of pandemic COVID-19.**
